Other Points

A deposit of £100.00 is required by all users. This is fully refundable on termination of the contract.

Bills will be dated the 1st of each month and will be received by email no later than the 12th of the same month. Payment will then be taken from the chosen credit card or bank account on the 15th of that month.

Each user will have a £30.00 spend cap. If this is exceeded your service will temporarily be stopped and we will contact you to take a payment mid-month. Service will resume once a payment has been received.





Full details

The following call types are free of charge, and included in the unlimited allowances:

- Calls made whilst roaming in the Inclusive Countries, shown below, to a local number within that country or any UK number.
- Calls received whilst roaming in the inclusive countries.

The unlimited text allowance can be used for texts sent whilst roaming in the Inclusive Countries, to a local number within that country or any UK number.

The inclusive data can be used in the UK and in the Inclusive Countries.

- If the inclusive data is exceeded, data will automatically be cut off. No data overage charges can be incurred.

The 125 minute worldwide bundle covers calls between countries (e.g. from Antigua to the USA). Once the 125 minute worldwide bundle has been used, calls between countries are charged at £3.00 per minute. This can be increased to 200 minutes for an additional £9.00 per month.





Alerts

Text and email alerts will be sent for the following:

- When 50%, 75%, 90% & 100% of the inclusive data has been used.
- Custom alerts can be set if required.
